War Against Rape (WAR), Karachi hails legal victory in the rape case of a 6 year old girl child, which was reported on May 4th, 2009. On July 31st, 2015 District and Session Court (East), Honorable Judge Mrs. Mushtari Khanam pronounced the accused guilty under section 376/PPC, 364-A, 376(i), 511/PPC. He was accused to 14 years of imprisonment. He is also liable to fine Rs. 50, 000 which shall pay by the accused to the complainant and in case of default in payment of fine he shall suffer for two months more. WAR commends the efforts of their Advocate Asiya Muneer who, along with Additional District Public Prosecutor/ Mr. Sanaullah Memon, ADPP for the state worked tirelessly to ensure that this heinous crime doesn't go unpunished.

War Against Rape (WAR), Karachi hails also legal victory in the rape case of 18 years old girl, which was reported on November 11th, 2010. On October 17th, 2015. Additional Session Judge Third Malir, Honorable Judge Mr. Sohail Pervaiz Qureshi pronounced the accused guilty under section 376/PPC. He was accused to 10 years of imprisonment. He is also liable to fine Rs. 20, 000 which shall pay by the accused to the complainant and in case of default in payment of fine he shall suffer for six months more. WAR commends the efforts of their Advocate Asiya Muneer who, along with Additional District Public Prosecutor/ Mr. Jamal Nasir Baloch, DDPP for the state worked tirelessly to ensure that this heinous crime doesn't go unpunished.
